## Baby Steps

Parent & Child      9 – 18 MONTHS      45 MIN SESSIONS

## Little Leaps

Parent & Child      18 MONTHS – 3 YEARS      60 MIN SESSIONS

Our programmes are designed for both the child and their accompanying adult (parent or carer).  
The only requirement is that the child feels safe and comfortable with the adult by their side.

### Sessions are structured to assist:

- Development of spatial orientation and body awareness
- Development of imagination and creativity
- Working on coordination and memory
- Strengthening the bond between adult (parent/carer) and child
- Learning how to actively spend creative play time with the child

### Sessions would include:

- Interactive songs; developing movement, speech and memory
- Story time with puppets and props; developing imaginative play
- Fun with musical instruments; developing the musical ear and rhythm
- Sensory and Messy play\*, developing senses and motor skills

### What is Sensory and Messy Play?

Throughout the term, some classes will include sensory and messy play sessions that engage your little one's senses, helping them to explore and make sense of the world around them. These activities spark creativity, support sensory development, and strengthen both gross and fine motor skills. Allowing toddlers the freedom to 'make a mess' (usually in a contained tray) is a natural and valuable part of learning—one that nurtures curiosity and builds creative confidence. And don't worry! Every product used in messy play is natural/non-toxic, safe-to-taste and child friendly.

**STEPPING STONES** will take place in a safe and caring environment at our studios at M Space.

A changer is available on site should you wish to change your toddler after class. Please bring a spare towel and wipes to each session.
